ARTICLES OF INCORPORATION

SEP 10 2008

OF

WISEBURN 21st CENTURY CHARTER SCHOOLS

a California Nonprofit Public Benefit Corporation

ARTICLE I

The name of the corporation is Wiseburn 21st Century Charter Schools (the "Corporation").

ARTICLE II

A. This corporation is a nonprofit Public Benefit Corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.

B. The specific purpose of this corporation is organized and operated (the "corporate Purpose") is

B.1.

a) to establish and operate public charter schools within the State of California that will provide educational instruction and other education-related programs to students residing in California; and

b) to have in furtherance of the foregoing purpose, all the powers which are now, or may hereafter be, conferred upon corporations organized under the Nonprofit Public Benefit Corporation Law, and to do everything necessary, suitable, useful, proper, convenient or incidental to any one or more of the said objects or purposes, and in carrying on its business, to do any and all things and exercise any and all powers which a natural person could do and exercise, or which it now or hereafter may be permitted to do by the laws of the State of California.

ARTICLE III

ARTICLE IV

- A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Internal Revenue Code section 501(c)(3).
- B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
- C. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from income tax under Section 501(c)(3) of the Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Code.

ARTICLE VI

The property of the Corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of the Corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Code.

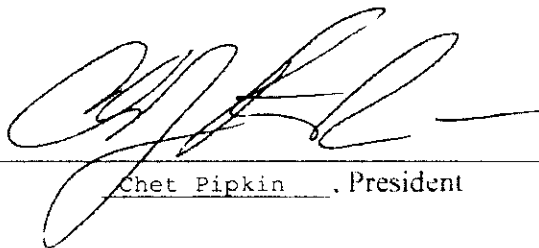

3. The foregoing amendment of Articles of Incorporation was duly approved by the board of directors on March 15, 2013.

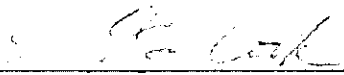
